# 5. Presentation – Wathaurong Rulebook Refresh project

Wathaurong's Board of Directors and the CEO presented their vision of placing the Rulebook back into Community hands and shaping the Refresh with Community voices. The Rulebook Refresh will be split into two phases of Community consultation before the agreed final draft is taken to a Special General Meeting for membership endorsement.

**Phase One:** to address the core legal requirements that require pre-approval from our regulating body Consumer Affairs Victoria (CAV)

**Phase Two:** to review the rest of the Rulebook to have it suit the needs, goals and language of the Wathaurong Community.

#### Presentation

The CEO presented a slideshow to introduce Community to the process that that the Refresh will follow and the changes that require pre-approval from CAV. The main changes can be summarised as:

## Item 5 – Objectives of the Co-operative

Reviewing the objectives of the Co-operative to better reflect that we want the organisation to be focused on in engaging our Community

## Item 7 - Active Membership Provisions

Looking at the requirements of "active" membership, and what that might mean for members who are still connected with community, but possibly living off country for a period of time

## Item 8 – Qualifications required for membership

Reviewing the eligibility requirements for becoming a registered member of the Co-operative, including the boundaries of the area serviced

Looking to replace the current complex explanation of the boundaries in the rules with a visual map

## **Community discussion**

Suggested themes that the Rulebook should represent:

- Inclusiveness Community getting together, knowing each other, kids growing up together, introducing new members in appropriate and safe ways
- History Community should understand the origins of the Co-operative and what and why
  people came together to create it
- Community Control what is our definition of a Community Controlled organisation
- Respect for active membership across the board, e.g. potentially the weight of their voice/vote
- Honesty the Co-operative as a safe place for difficult conversations
- Reciprocity Wathaurong as a Community of contribution, not just taking
- Identity we are the growers of our identity and must stop the genocide of our cultural identification
- Diversity and talent embrace these qualities in Community

General discussion around other issues to explore:

- Membership (application and maintaining an active status) review the appropriate of requirements with consideration for the nature of the diverse nature of Wathaurong Community
- Membership drives and incentives to apply for membership
- Eligibility for accessing services the need for direct connection for non-Aboriginal people; and prioritisation for members

- Take advantage of the diversity in Community with activities that bring everyone together from children to Elders
- We need to reengage lost members
- Return to the openness of the past
- Frame who we want to be (objectives) succinctly and in simple terms

# **Boundaries discussion**

- Co-benefits of extending the boundaries to include Werribee community support and organisation support vs refocusing on improving existing services within current boundaries
- Cultural boundaries vs service boundaries
- Where does Colac fit as a priority
- Impacts on relationships or partnerships with neighbouring ACCOs and other service
- Need to understand the implications of accepting funding and Wathaurong's responsibilities

# **Active membership discussion**

- Temporary relocation from Wathaurong Country
- Available housing might impact on someone's ability to live on Country

# 6. Other General Business

- Discussion about the need to understand full implications of the obligations Wathaurong accepts when it granted funding, and if it aligns with community goals.
- Community offered good news stories, including:
